- ✓ Current and previous year's 1099's (if you receive retirement Income such as Social Security, Pensions etc. and award letter)
- ✓ Current and previous year's Federal Income Tax Returns (All pages of return. Business, Partnerships and K-1's if applicable)
- Two (2) current months of Bank Statements (Checking, Savings, 401K, Stocks, IRA etc. Please send entire bank statement.)
- ✓ Homeowners Insurance (Just front page that lists agent, phone & premium)
- Copy of Driver's License for each borrower.
- Current mortgage statement and Homeowners Insurance documents for any additional properties you may own. (if applicable)
